The **Fort Bend County** budget will raise more revenue from property taxes than last year's budget by an amount of \$16,873,202 or 3.33%, and of that amount \$10,095,819 is tax revenue to be raised from new property added to the tax roll this year.

The **Fort Bend County Drainage District** budget will raise more revenue from property taxes than last year's budget by an amount of \$575,106 or 4.60%, and of that amount \$248,055 is tax revenue to be raised from new property added to the tax roll this year.
