

NOTICE OF ELECTION

TO THE QUALIFIED VOTERS OF FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 4 AND ALL OTHER INTERESTED PERSONS:

Notice is hereby given that a sales and use tax election (the "Election") will be held for and within Fort Bend County Emergency Services District No. 4 (the "District"), pursuant to the Order Calling Sales and Use Tax Election adopted on July 29, 2025 by the District's Board of Commissioners (the "Board"). Said Order is on file in the District's Designated Agent's office located at 2929 Allen Parkway, Suite 3450, Houston, Texas 77019-7120, where any interested person may refer to it for all purposes.

The Election will be held on Tuesday, November 4, 2025 between the hours of 7:00 a.m. and 7:00 p.m., at all Fort Bend County countywide polling places described on the attached **Exhibit "A"**. The purpose of the Election is for the duly qualified resident electors to vote regarding the imposition of a sales and use tax by the District.

All duly qualified resident voters will vote for or against the following proposition:

	() AGAINST	The adoption of a local sales and use tax in Fort Bend County Emergency Services District No. 4 at a rate not to exceed two percent (2%) in any location in the District.

The officers of such Election have been appointed by the Fort Bend County Commissioner's Court.

Early Voting by personal appearance shall be conducted during the times and at the locations listed on the attached **Exhibit "B"**.

The Early Voting Clerk shall receive applications for early voting ballots by mail through 5:00 p.m. on Friday, October 24, 2025, which is 11 days prior to the Election. The Early Voting Clerk shall receive voted early voting ballots through 7:00 p.m. Tuesday, November 4, 2025, if the ballot is not postmarked, or through 5:00 p.m. on Wednesday, November 5, 2025, if the ballot is postmarked.
