

NOTICE OF ELECTION

TO THE DULY QUALIFIED VOTERS OF FORT BEND COUNTY, TEXAS, WHO RESIDE IN FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 3 AND ALL OTHER INTERESTED PERSONS:

Notice is hereby given that a sales and use tax election (the "Election") will be held for and within Fort Bend County Emergency Services District No. 3 (the "District"), pursuant to the Order Calling for the Sales and Use Tax Election passed and adopted on January 22, 2025, (the "Order") by the District's Board of Commissioners (the "Board"). Said Order is on file at 2727 Allen Parkway, Suite 1100, Houston, Texas 77019, where any interested person may refer to it for all purposes.

(1) The District has entered into an Agreement relating to joint elections to be held May 3, 2025 (the "Agreement") with Fort Bend County, Texas (the "County") for the purpose of having the County's Election Administrator provide certain joint election services and equipment needed by the District in connection with the Election on May 3, 2025. Said Agreement is on file at 2727 Allen Parkway, Suite 1100, Houston, Texas 77019, where any interested person may refer to it for all purposes.

(2) The District has adopted the County's early voting and election day polling places for purposes of said Election. The Election will be held on Saturday, May 3, 2025 between the hours of 7:00 a.m. and 7:00 p.m., at all Fort Bend County countywide polling places described on the attached **Exhibit "A"**, which are, pursuant to Section 271.003(b), Texas Election Code, are declared to be public places for the purposes of this Election. The purpose of the Election is for the duly qualified resident voters to vote regarding the imposition of a sales and use tax by the District.

(3) Early voting shall be conducted by **John Oldham**, the Early Voting Clerk. Early voting by personal appearance will be conducted on April 22, 2025 through April 29, 2025, at the locations, dates and times specified on the Early Voting Schedule, attached hereto as **Exhibit "B"**, which locations, pursuant to Section 271.003(b), Texas Election Code, are declared to be public places for the purposes of this Election.

(4) Applications for ballot by mail and ballots voted by mail for the Election for those voters who are entitled by law to vote an early voting ballot by mail shall be sent by regular mail to the Early Voting Clerk's official mailing address to: Early Voting Clerk, Fort Bend County Elections Office, 301 Jackson Street, Suite 101, Richmond, Texas 77469-3108; or by common or contract carrier to: Early Voting Clerk, Fort Bend County Elections Office, 3730 Bamore Road, Rosenberg, Texas 77471. Applications for ballots by mail must be received no later than the close of business at 5:00 p.m. on Tuesday, April 22, 2025. The location of the main early voting polling place is 3730 Bamore Road, Rosenberg, Texas, 77471.

(5) The Election will be conducted in compliance with the provisions of the federal Help America Vote Act (HAVA), the Texas Election Code, and all other applicable laws, and each polling place will have at least one voting system accessible to individuals with disabilities.

(6) Voting in said Election shall be on paper ballots and/or electronic ballots. Ballots, voting instructions and the propositions will also be available in the English and Spanish languages for persons requesting same.

(7) The following proposition(s) shall be submitted to the duly qualified resident voter at said Election:

Shall the Board of Commissioners of Fort Bend County Emergency Services District No. 3 be authorized to adopt, assess, levy and collect a sales and use tax to be used for any purpose for which ad valorem tax revenue of the District may be used at a rate not to exceed two percent (2%) in any location in the District in accordance with the Constitution and laws of the State of Texas, particularly (but not by way of limitation) Section 775.0751, Texas Health and Safety Code, as amended, within the District?
